# Our Focus—Promoting Education

ASPE endeavours to provide financial assistance, counselling and promote awareness in obtaining education among disadvantaged people. ASPE started its projects by identifying deserving areas of need in Pakistan aiming to provide support for school education, trade education and higher education students. ASPE have engaged volunteers and institutions in Pakistan to identify deserving areas of need, identify deserving students, gather and assess their financial standing and then manage disbursement of funds and track their academic performance. Together with its volunteers and institutions ASPE works out the final selection of students, issue funds, provide advice and seek for expansion of its support base. ASPE sources its funds by donations and sponsorship from Australian and overseas community.

## OUR PROGRAMS



*Pakistan School Education Scholarship Program*

### Pakistan School Education Assistance:

Over the past few years, ASPE has been supporting school students from year 1 to year 10 in three different locations in Pakistan – Barotha, Bahawalpur and rural area of Faisalabad. With the help of volunteers in these areas, ASPE is able to provide funds, monitor progress and provide counselling to disadvantaged students and their parents.

### Pakistan Trade Education Assistance:

ASPE had granted financial assistance in the area of civil, electrical and mechanical trade education. This area of need targets to help needy candidates acquire necessary skills quickly to support themselves and their families. ASPE provide trade assistance in Government Colleges of Technology in Lahore.



### Pakistan Higher Education Scholarships:

ASPE has been providing scholarships to 20 deserving students in University of Agriculture Faisalabad every year. ASPE works with the university administration directly to advertise, select and manage students. On the average, ASPE has been able to sponsor only 1 student out of 25 students who apply.



## Help Disadvantaged Students

**Sponsorship:** You can help these disadvantaged students by sponsoring students for their term of education. The cost of sponsoring a child is as follows:

**School Student:** \$250 per year. Sponsors are encourage to commit for 5 years.

**Trade Education:** \$300 per year. Sponsors are encourage to commit for the entire course-work of 3 years.

**University Student:** \$700 per year. Sponsors are encourage to commit for the entire course of 4 years.
